Preface

In accordance with [Business and Professions Code Section 12533 \(c\)](#), the Department of Food and Agriculture (CDFA), Division of Measurement Standards (DMS) has developed a new electronic Field Reference Manual (e-FRM) for 2025. This e-FRM is formatted and designed for online use primarily for Registered Service Agencies (RSAs) and service agents (employees of an RSA). It is statutorily mandated that RSAs possess a copy of the California Code of Regulations (CCR) Title 4, Division 9 (commencing with Section 4000 et. seq.) to complete their initial or renewal registration application. This e-FRM provides an RSA with online access to the most current copy of California regulations related to weighing and measuring devices used for commercial purposes. Others not doing business as an RSA may also use this document and once familiarized with it, find out how useful this online tool is and just how easy it is to navigate California's regulations.

Introduction

Occasionally, and throughout the year, the provisions of CCR Title 4, Division 9 change due to an addition, modification or repeal of certain sections of regulation. This new e-FRM includes real-time, user-friendly links to the most current published requirements updated regularly on the publishing company's website, Thomson Reuters – [Westlaw](#). This new format includes collapsible / expandable headings where an RSA can expand on any chapter of interest and navigate to the desired section(s) of regulation. To use the new e-FRM format, click on any of the chapters, articles, or sections (code numbers or titles) to view the official, published language of that section. Additionally, any [underlined text](#) in this document links to associated California laws, regulations or additional information for further reference.

An RSA may navigate this e-FRM with ease and confidence knowing they are referencing the most up-to-date weights and measures regulations. This e-FRM may be downloaded as a [portable document format \(PDF\)](#) file or accessed online using a desktop computer or any mobile device with internet access. This new e-FRM format complies with the Americans with Disabilities Act (ADA) by offering the "Read Aloud" functionality of this and other linked documents and websites. Linked videos also offer closed captioning functionality. In the open document or video, either right-click or choose the universal icon(s) to begin audio reading  or text display. Although it is a printable file, please go paperless and consider making use of its new electronic capability!

Some sections of this e-FRM contain one or more CDFA-DMS NOTES that provide quick reference information about the provisions of that section. These notes are intended to assist an RSA with becoming more familiar with that section before linking to it.

Before using this document, please review [Appendices A-E](#) for additional instruction, statutory and regulatory references, and tutorials and training courses included to improve an RSA or service agent's baseline knowledge of regulations, rulemaking, and inspecting and testing devices used for commercial purposes.



Appendix A. Westlaw



UPDATES: This icon updates the Westlaw search engine and refreshes the webpage with the latest updates. This is usually done automatically each time the RSA logs in to Westlaw. NOTE: An RSA must ensure that their web browser and java script applications are also updated before use; Click on Westlaw’s HELP icon for more information and review HELP description below.

SEARCH: This icon is the RSA’s most effective reference tool in Westlaw as it opens the search engine function. Further [Search information and instructions](#) on using Westlaw as a search engine and descriptions of various types of search criteria the RSA may use to navigate to a desired regulatory section are below:





An RSA must be familiar with this practice and be knowledgeable of the exceptions in Section 4001 and additional requirements adopted in subsections of Section 4002 for

each type of commercial device they repair, inspect, test, and place in service. On a computer or mobile device with internet access, an RSA must open:

1. the current edition of NIST Handbook 44, Section 1.10. General Code and the specific section code of the commercial device being worked on e.g., Section 2.20. Scales Code for a commercial weighing device;
2. CCR Title 4 Section 4001; and
3. the specific subsection of Section 4002 applicable to the commercial device being worked on.

The provisions of any referenced section of NIST Handbook 44 in CCR Section 4001 shall not be applied to the device, while any provisions in the corresponding subsection of Section 4002 must be applied concurrently and in addition to those in NIST Handbook 44. This e-FRM has “NOTES” in these sections to assist an RSA with becoming familiar with this practice even while working in the field.
